

Town of Farmington—2025 Taxes

Treasurer's Tax Collection

Your tax bill has three coupons on the bottom.

- The 1st coupon is for paying the **1st installment** to the Town of Farmington by January 31, 2026.
- The 2nd coupon is for paying the **2nd installment** to be paid by July 31, 2026 to the La Crosse County Treasurer.
- The 3rd coupon is for paying the **full amount** to the Town of Farmington by January 31, 2026.

Please read the back of your tax bill as it contains important information regarding your tax bill and failure to pay timely. Listed below are different options to pay your tax bill.

1. Mail in your tax payment to the following address:

2. Drop your payment in the drop box located by the front door of the Farmington Town Hall door. The drop box will be checked daily between December 15, 2025 and January 31, 2026.
3. Pay online with bank account or credit card. **This service will charge the taxpayer a transaction fee. I am unable to take payments over the phone.**
4. You may bring your tax payment in person to the **Farmington Town Hall** on the following dates:
Saturday, December 27, 2025—8:00 a.m. – 11:00 a.m.
Monday, December 29, 2025—4:00 p.m.—7:00 p.m.
Wednesday, January 28, 2026—4:00 p.m.—7:00 p.m.
Saturday, January 31, 2026—8:00 a.m. – 11:00 a.m.

If these times are not convenient for you, please call me to set up another time. **Please leave a message if there is no answer.**

2026 Dog Licenses

All dogs in the Town of Farmington must be vaccinated against rabies and must be licensed by 5 months of age.

A dog license can be purchased between now and March 31 to avoid a late fee and citation. If you registered a dog (s) last year, you will find a blue sheet enclosed. This sheet show rabies information. If the rabies are expired for your dog, you will need to provide proof of current rabies vaccination before a license can be issued. Licenses are purchased from the town treasurer. Licenses can be purchased at the above times or call Jodi at (608)386-6187 to set up other arrangements.

The fee to license your dog is \$12.00 for an altered dog and \$23.00 for an unaltered dog..

If you fail to license your dog by March 31st, you must purchase a dog license from the County Clerk's office and pay a late fee of \$25.00 plus the cost of the dog license. This also applies if you get a new dog and fail to license it, if your puppy turns 5 months old and you fail to license it, or if you move into the township and fail to license it within 30 days.
